- Horseback Class
 - Peter Gonnet presented how the Horseback class was handled according to Canadian
 - There was discussion of differing ways to handle the Horseback class.

 - Any dog of any age can run in the horseback class.
 - Any handler can run in the horseback class.
 - Handlers eligibility in foot classes will not be effected by participation in the horseback class.
 - The Horseback class is a stand alone class with no divisions, this is the only sanctioned horseback class.
 - NCA will track and sanction the Rodear Open class, but no other Rodear
 - NCA will track and sanction the American Ranch dog trials advanced class, but no other American Ranch dog classes.
 - NCA will track and sanction a horseback jackpot class held by another organization if all classes of handlers are allowed to run without its affecting handler eligibility.
 - This motion was seconded by Lincoln Rogers and passed with a majority vote, with Sonny Mahurin abstaining.
- Grievance
 - There was discussion of a grievance letter received in the NCA office regarding election proceedings.
 - Duane Packard, President, appointed Charles Holt as Chairman of a grievance committee to investigate these allegations.
