President's Report

• Tim Gifford and Bob Wagner will be going to Meeker next week to dog break the Finals cattle. There are 300 to work with so any that are not appropriate for Finals can be culled.

Treasurer's Report

- Our account now has \$74,000 after giving \$20,000 to the Meeker folks. Partnering with Meeker has saved us a great deal of money.
- Entry fees are now all in.
- There is still some money yet to come in from clinics and puppy donations.
- Less than two months into the new qualifying year, there are 67 Open dogs with points and 37 Nursery dogs.
- There was some discussion of converting prize monies to Canadian for our friends up north, so they don't lose so much.

Old Business

- Main Field Course
 - The schedule has the final day of Open as lasting only four hours. How can we make that work? There was some discussion of shortening the outruns, but many wanted to keep them as is.
 - There was discussion of how to set the double lift to have the handler call for the second set or have the setout folks bring the second set out when the first set reaches a particular point. The consensus was to have them set out when the first set reach a particular point, but no definite decision was made at this time.
 - Discussion of having the fetch panels a one-shot deal on the final day. The course is currently set that way.
 - Discussion of the Nursery course being too similar to the Open course, and any dogs that are running Open and also Nursery would have an advantage. The solution might be to reverse the direction of the drives on the preliminary days. Most agreed, but it was decided to look at it once we all get there.
 - Discussion about some of the Horseback courses; they might be a little too complex for the time we have. This will also be considered when we get there.

- Project Dog
 - There was discussion of how to get the news of this test to the membership without necessarily endorsing it.
