 - Mr. Schilke will be under probation for a period of one year beginning January 1, 2019.
 - Any misconduct by Mr. Schilke during that period will result in at least a one-year suspension.
 - Randy Mooney seconded.
 - Brian Jacobs moved to amend the motion to a six-month suspension.
 - Campbell Forsyth seconded. Amendment passed by a four to three margin.
 - Forsyth, Packard, Jacobs, Mahurin voted yes. Mundorf, Knipmeyer, Mooney voted no.
 - Motion as amended passed unanimously (letter attached below).

Campbell Forsyth moved to adjourn. Brian Jacobs seconded.

As the Board of the Outback Stock Dog Association we feel that your conduct as a competitor at the Nebraska State Fair in regard occurred in the spectator area was totally unacceptable at a trial that is sanctioned by the Outback Stock Dog Association.

We as a club are trying to promote good sportsmanship and provide a positive role model for new people entering the sport. As well a experience for the spectators. Therefore, we feel it necessary to suspend you from competing in Outback Sanctioned Trials until Janua With that being said, if one of the trial hosts feels that you should run at one of their trials we cannot and will not stop you, but we we earned. We are also asking that the NCA board honors our wishes and not accept any points earned from any NCA sanctioned trial (September 1, 2018- January 1, 2019).
