Board of Directors Meeting Phone Conference July 29, 2021

President's Report

More changes will be made once a new secretary is hired.

New Business

- NCA Secretary
 - Discussion was held on a possible secretary candidate.
- Sonny Mahurin made the motion and Charles Holt seconded to offer the job to Angie Brooks.
- Pay will be kept the same for now at \$500/month.
- 1st Year Novice program
 - The rule that allows a First Year Novice to get a free year's membership to NCA was discussed.
 - This rule was initially started with a one-year trial period.
 - Sonny Mahurin made the motion and Barry Breemersch seconded to make this rule permanent; motion passed.
- Nursery age dogs/year end
 - A long discussion was held about the Nursery age dogs and the differences of the year-end between different sanctioning organizations.
 - No action was taken and the item was tabled.
- Finals Co-ordinator
 - Duane Packard talked about Becca Barron being the NCA Finals Coordinator. It
 would be a new position within the NCA and whose focus will involve dealing with
 organizing and sponsorship of the NCA Finals.
 - Duane Packard was given the board's approval to discuss this more with Becca.
- Finals Videos
 - It was agreed that the videos taken at the 2021 Finals were the property of the NCA.
 - Sonny Mahurin, who organized the video project, currently has possession of the videos and will get the files to the NCA.
 - He mentioned they could be used to be a fund raiser if NCA so decided and
 offered to work on that. It was decided that would be a job that would fall
 under more of the secretary's duties once that position was filled.
