Old Business

- Novice Finals
 - Brian Jacobs is working to organize the Finals.
 - Lots of new members in West Coast for Novice.
- California trial sanction issue
 - Brian Jacobs is working with the trial host to resolve.
- Rules review
 - Intermediate
 - A problem has come up when and Intermediate runs a dog then an Open handler runs the dog, then the Intermediate runs the dog again.
 - Clarification is needed on this phrase from the NCA class rules:
 - "An intermediate handler may acquire a dog of any level at any time during the qualifying year and make that dog parts of his/her intermediate team. However, once a dog is part of an intermediate team, it must, during that qualifying year, be run only by that handler to maintain the intermediate eligibility of that team."
 - The Board interpreted that the Intermediate team is just that team and that if an Intermediate has a dog and allows any other handler to run that dog that the Intermediate forfeits eligibility for that year's National Finals.
 - Open
- "A handler who has competed in an NCA sanctioned open class is no longer eligible to compete in the Intermediate or Novice class."
- Campbell Forsyth moved to remove 'NCA sanctioned', Duane Packard seconded, motion passed.
- Intermediate move-up rule
 - "At the end of a qualifying year, unless they attend and compete at the National Finals, the top two intermediate point earning handlers are no longer eligible for the intermediate class."
- Motion made by Patty Koller to remove the phrase "unless they attend and compete at the National finals". Motion seconded by Duane Packard, motion passed.
- Novice
 - It was clarified that a Novice handler and dog are a team as far as keeping points.

New Business

- Horseback/Rodear.
 - Open is Open.
 - Non-Open could be given as horseback only points if we wanted to sanction with the Rodear.
 - Motion made by Campbell Forsyth to co-sanction Open Rodear as Open NCA but Non-Open will be sanctioned as Horseback only since the NCA has separate classes. Motion was seconded by Jeff Christiansen, motion carried.
- NCA Futurity
 - To be held in the spring.
 - Sonny Mahurin offered to host.
 - Board agreed and supported.
